Both our Elk Point Elementary Annual Education Results Report and our Education Plan align with St. Paul Education's plans and reports.

#### CONTEXTUAL INFORMATION and STAKEHOLDER ENGAGEMENT:

Elk Point Elementary School is located in the town of Elk Point, population 1400, which is located in the eastern part of the St. Paul Education school division. The school serves approximately 200 students annually. The total staff consists of 12.5 teachers, 9 educational assistants, a learning commons facilitator, 1.5 secretaries, a student counselor, a 0.3 computer technician and 4 maintenance and custodial staff. The school serves students from the Town of Elk Point as well as some students from Kehewin Cree Nation, Frog Lake First Nation and from Lindbergh/Heinsburg communities. The main industries in the area are agriculture, oil and gas.

As per section 12 of the School Councils Regulation the Elk Point Elementary Parent Council is provided the opportunity to view and provide feedback on provincial assessment results and the school's Education Plan.

Caution should be used when interpreting high school completion rate results over time, as participation in the 2019/20 and 2020/21 Diploma Exams was impacted by the COVID-19 pandemic. In the absence of Diploma Exams, achievement level of diploma courses were determined solely by school-awarded marks.

Participation in the Provincial Achievement Tests and Diploma Exams was impacted by the first in 2018/19, as well as by the COVID-19 pandemic in 2019/20, 2020/21 and the January 2022 Diploma Exam administration. 2019/20, 2020/21 and 2021/22 are not included in the rolling 3-year average. Caution should be used when interpreting trends over time.

Aggregated PAT results are based upon a weighted average of percent meeting standards (Acceptable, Excellence). The weights are the number of students enrolled in each course. Courses included: English Language Arts (Grades 6, 9, 9 KAE), Erançais (Ge et 9 année), French Language Arts (Ge et 9 année), Mathematics (Grades 6, 9, 9 KAE), Science (Grades 6, 9, 9 KAE), Social Studies (Grades 6, 9, 9 KAE).

Students most likely impacted by these security breaches have been excluded from the provincial cohort. All students have been included in school and school authority reporting. Caution should be used when interpreting these results.

Aggregated Diploma results are a weighted average of percent meeting standards (Acceptable, Excellence) on Diploma Examinations. The weights are the number of students writing the Diploma Examination for each course. Courses included: English Language Arts 30-1, English Language Arts 30-2, French Language Arts 30-1, Erançais, 30-1, Mathematics 30-1, Mathematics 30-2, Chemistry 30, Physics 30, Biology 30, Science 30, Social Studies 30-1, Social Studies 30-2.

At the PAT Acceptable Standard, our results are 20% above the division average and 14% higher than the provincial average, though they are 11% lower than our previous 3 year average. Our Standard of Excellence results, while higher than both the division and provincial averages, did decline by 10% from our previous 3 year average.

The decline in our students' performance for 2021-22 can be attributed to the negative impact that the pandemic had on student learning.

Our school results are above the division and province for the Acceptable Standard in all subjects, though lower than our previous 3 year average. The number of students achieving the Standard of Excellence is lower than our previous 3 year average with a significant drop in Math.

#### LOCAL COMPONENTS

#### **Continuum of Supports and Services**

School Authorities are responsible for ensuring students have access to a continuum of supports and services, including specialized supports and services, consistent with the principles of inclusive education.

Elk Point Elementary strives to meet the needs of all learners through a continuum of supports and services.

Processes and strategies include:

- Coordinator of Student Supports is responsible for overseeing the development of universal, targeted and individualized programming to support all students.
- School based Student Support Team meets once in every six day cycle to identify areas of student need and evaluate extra supports provided.
- Individual Program Plans, Behavior Support Plans and Medical Support Plans are created to ensure staff are aware of, and accountable for meeting, student needs.



- Staff work collaboratively with the St. Paul Inclusive Education Team which includes an Occupational Therapist, Speech Language Pathologist, SLP Assistant and a Program Assistant.
- St. Paul Inclusive Education Literacy Team identifies and provides extra support to at risk students.
- Early Intervention Programming is provided through Program Unit Funding (PUF) and Kindergarten Specialized Learning Support (KSLS).
- Family School Liaison Worker (FSLW) provides targeted mental health support to students.
- Through the Together We're Better Mental Health Capacity Program, our Success Coach provides universal programming in the areas of health and wellness.

#### **Growth in Reading**

With a lack of provincial achievement results due to the cancellation of PATs during the pandemic, the division-wide STAR reading scores for the last three years are indicated in Grades 3 & 6.

While our results continued to be higher than the division over the last three years, the percentage of students reading at or above grade level is not as high as we would like it to be. Again, this is an indication of the effects of the pandemic on student learning. The 2022-23 data comes from the STAR test results in November 2022.

#### **Implications for Education Plan**

- Continue to provide 20 minutes of AR reading time daily for students in grades 2-6 and to administer the STAR assessment 3 times per year to track student progress. Some grade 1 students will join the program later in the year.
- Continue to explore and implement strategies based on the Science of Reading.
- Create a structured EPE Literacy Framework with continuity from grade to grade. This framework will be expanded upon when we receive the division framework that is currently in development.
- Maintain EPE representation on the division Literacy and Numeracy committees.
- Continue, through our School Wide Math Collaboration Project, to identify areas of need and utilize school wide strategies to address those needs.
- Continue to provide the student supports that we have in place and assess the need for further supports.





The pandemic led to a lot of disruption to learning and to the way that we were able to operate our schools during that time. The negative effect of this disruption can be seen in our significantly decreased results from all respondents.

#### LOCAL COMPONENT

#### **Professional Learning, Supervision & Evaluation**

School authorities are responsible for supporting teaching and leadership quality through professional learning supervision and evaluation processes.

- School administration supervises teachers on an ongoing basis and completes formal evaluations when necessary.
- Principals meet with teachers to review their Professional Growth Plans including links to the Teaching Quality Standard and identifying areas where admin can provide additional support.
- Teachers do a mid year PGP check in with colleagues to assist them in remaining accountable to their plan.
- Principals meet with CO Senior Administration to review their Professional Growth Plans and ensure their accountability to the Leadership Quality Standard.
- Staff participate in division-wide professional development on topics such as trauma-informed education, residential school legacy, the Science of Reading, and bullying.

#### **Implications for the Education Plan**

- Determine highest areas of need to staff when planning school-based professional development.
- Ensure the school's PD plan allows staff collaboration time to review Professional Growth Plans.
